## BAC Resolution Declaring Failure of Bidding for Supply and Delivery of Brand New 6 Wheeler Boom Crane Truck

## **RESOLUTION NO. 01-2023**

WHEREAS, the Metro Cotabato Water District published the Invitation to Bid for PR#22-11-0768 – Supply and Delivery of Brand New 6 Wheeler Boom Crane Truck, with an Approved Budget of Contract (ABC) of Three Million Pesos (Php3,000,000.00) in the PhilGEPS on December 12, 2022 and in a conspicuous place at the premises of MCWD continuously for twenty three (23) days;

WHEREAS, the Pre-Bid Conference was conducted at the MCWD BAC Room and via zoom conference on December 20, 2022 and was participated by three (3) prospective bidders namely;

1.) ISUZU Tagum

2.) XOM Truck Trading and Services

3.) The Legacy Truck

WHEREAS, the bid-opening conference was held on January 04, 2023 at MCWD Conference Room and two (2) prospective bidders purchased and submitted the bidding documents, to wit:

1.) RCSL Motor Vehicle Trading purchased the bidding documents on January 04, 2023 with O.R. No. 000193 amounting to Five Thousand Pesos (Php5,000.00) and submitted their bid on January 04, 2023 at 8:25 in the morning; and

2.) XOM Truck Trading and Services purchased the bidding documents on January 04, 2023 with O.R. No. 0001922 amounting to Five Thousand Pesos (Php5,000.00) and submitted their bid on January 04, 2023 at 9:25 in the morning.

WHEREAS, the bidders were able to submit the required documents. Thus, they were found to be **ELIGIBLE & COMPLYING** on the Eligibility, Technical, and Financial component of the bid as to the presence of the required documents but subject for Technical and Post Evaluation;

Technical Specifications \*\*Statements of "Comply" or "Not Comply" must be supported by evidence in a Bidders Bid and cross-referenced to that evidence. Evidence shall be in the form of manufacturer's un-amended sales literature, unconditional statements of specification and compliance issued by the manufacturer, samples, independent test data etc., as appropriate. A statement that is not supported by evidence or is subsequently found to be contradicted by the evidence presented will render the Bid under evaluation liable for rejection\*\*. Thus, the two bidders were not responsive as stated herein.
