	<p>Terms and Conditions for Compressive Strength Tests on Concrete Hollow Blocks (CHB)</p> <ul style="list-style-type: none">• Eight (8) specimen blocks for each size (4" & 6" thk.) shall be randomly selected by MCWD representative for testing the compressive strength of CHB's. ✓• The blocks shall be tested within 3 days after delivery to the testing laboratory. ✓• The age of each block shall be 28 days. The age shall be reckoned from the time of the addition of water to the dry ingredients. ✓• The average of 8 blocks strength will be the final compressive strength of the concrete masonry unit which shall not be less than 500 psi. ✓• The compression testing machine shall be as per standards of the Department of Public Works and Highways (DPWH). ✓

This Supplemental/Bid Bulletin shall form part of the Bidding Documents. Any provisions in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly.
